# **CHILDREN & YOUTH SERVICES**



The KFICCC summer program had over 170 children enrolled, all of whom enjoyed wonderful experiences including field trips and on-site paddle boats.

In early September, Thomas Bamrick joined the team as Director of Children & Youth Services. He recently relocated from Florida and brings with him a wealth of experience. One of his first projects is to complete KFICCC's accreditation process.

Montgomery County Public Schools renovated the front half of the KFICCC building over the summer. It has become MacDonald Knolls Early Childhood Center, a preschool program for income-eligible children.

KFICCC'S annual toddler boogie was held in October, and this year's theme was "Monster Mash." This muchloved non-scary Halloween party is always a hit with families, and made over \$4,000 to support the program. Volunteers from James Madison University Alternative Break Program (above) helped with setup, cleanup and staffing games at the event.

Bookshelves in five classrooms were scraped, sanded and painted over two Saturdays by a large group of volunteers from the **Church of Jesus Christ of Latter-Day Saints** in Silver Spring.

# **COMMUNITY LIVING SERVICES**

As part of a complete reorganization, Residential Services was renamed Community Living Services, to better reflect the supports provided. A new staffing structure is in place, consisting of one Associate Director, two Assistant Directors, six Coordinators, four Medical Appointment Technicians and eight House Managers. The overall goals are to reduce and/or redistribute the workload, decrease overtime and improve services. As of December, there will be 37 residential locations operated by The Arc in Montgomery County.

When people expressed wanting friendships and romantic relationships, staff facilitated group dinners among various homes so people could get to know each other. Residents who wanted to vote in the recent election were supported in exercising their civic duty.

Volunteers from **Our Lady of Good Counsel High School** participated in a father-student day of service by spending their Sunday morning completing outdoor cleanup projects at three homes. They were also invited to share breakfast with the residents.

The Greater Capital Area Association of Realtors donated \$2,500 for tree removal and pruning at two homes, their sixth year supporting The Arc.

## **URBAN THRIFT**

Urban Thrift sales for the last two months were the highest ever! The store staff have created new partnerships for receiving donations, including one with Target, and hosted tables at the Kensington Labor Day parade and Explore Kensington day. Local advertisements have been placed through ValPak and other publications, including a collective campaign for about 30 Kensington businesses with the tagline "I found it in Kensington!" In addition, a fall Eco-Fashion show partnership with local Kensington businesses was very successful. Similar events will be held quarterly to help draw customers who do not typically shop at thrift stores.



The 2018 Halloween Gala sold out—literally every seat in the room was taken this year! Over 230 people gathered to enjoy some spooky fun and also to support The Arc's programs. Several self-advocates and family members spoke about their lives, and the evening was capped off by a performance by Blue Spectrum. For the first time, all bidding was electronic, using personal smart phones or bidding stations at the event, which made checkout quicker. Altogether, it was a great evening for a great cause!

# FAMILY & COMMUNITY SERVICES

F&CS is now supporting over 100 people and has hired a full-time Community Builder to assist people in making more connections with their communities. This new staff is also charged with reinvigorating STAND Together, the agency's self-advocacy group.

Save the date for the Respite Resource Fair on Saturday, March 23. The location is the Activity Center at Bohrer Park, Summit Hall Farm in Gaithersburg. This will be an opportunity for people to learn more about respite care and to directly connect with vendors who provide respite care services.

# **VOCATIONAL & DAY SERVICES**

The TIP grant for customized employment was completed and as a result, two new staff positions were developed and more than 100 people gained information on customized employment. Staff has been building relationships with DORS (Department of Rehabilitative Services), with a goal of increasing referrals and funding sources.

The Transitioning Youth Retail Project (TYRP) no longer exists as a stand-alone program due to the ending of grant funding. The curriculum is being redesigned so that existing V&DS staff can offer the classes as needed.

Volunteers from **Aronson LLC** supported the annual V&DS picnic in May, engaging in fun activities with people being supported and serving lunch (right).

# **ADMINISTRATION**

All program divisions participated in Direct Support Professionals week September 9-15, honoring DSPs by hosting receptions where each person received a gift and gift card (below).

Three staff have been selected to participate in The Arc Maryland's Leadership Class of 2019. This class meets multiples times over the course of a year, and is designed to give rising leaders an opportunity to learn about all local chapters and the national chapter.

The lease on the Nebel Street location expires in July, so it's likely that the administrative offices will be relocated during the summer. Multiple locations are being investigated, with an eye toward those which can be made fully accessible and which have adequate parking.

Testing is currently underway with a new Document Management System designed to streamline processes and to serve as a shared repository of documents which doesn't require physical storage space. For the third straight year, the financial audit of the agency's records was returned with no material findings, a notable success for the finance department.

## **BEHIND THE SCENES**




