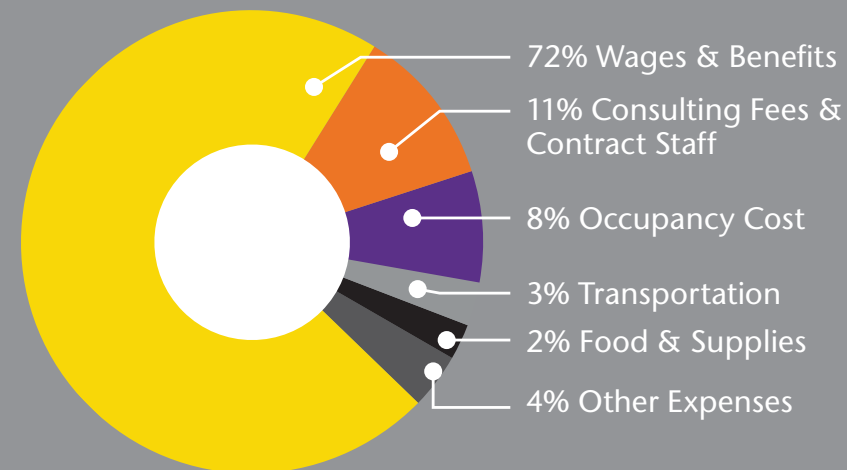

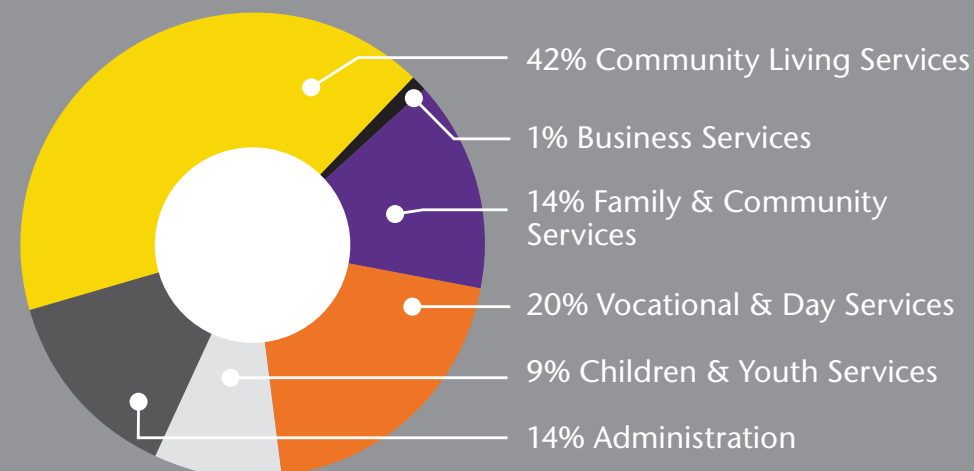
FY18 REVENUE: \$25,163,347
