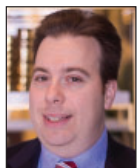
## Slate of Nominations for FY2021 Board of Directors

### **Nomination Process**

The slate of nominations for The Arc Montgomery County FY2021 Board of Directors was prepared from applications received through April 15, per the agency's bylaws. These applications were vetted by the Governance Committee and the resulting slate of nominations was approved by the current Board of Directors. The slate with short biographies of each person was distributed through email and posted on The Arc's website.

### **Elections**

Due to the COVID-19 pandemic, the final Slate of Nominations will be voted upon with the enclosed postcard ballots. Voting is restricted to current members of The Arc Montgomery County as of May 31, 2020. Ballots are pre-numbered to ensure no member votes more than once, but numbers are not linked to individual members.

**Ballots must be received by The Arc Montgomery County not later than Wednesday, June 24, 2020.** Only ballots distributed by The Arc Montgomery County and returned via U.S. mail will be considered valid.

Ballots will be tabulated and election results announced at the virtual membership meeting on Thursday, June 25, 2020 at 7 pm. Details for participating in this meeting will be shared on The Arc Montgomery County's website at least one week in advance.
