Living by yourself can be isolating, as Vadim knows first-hand. He craved connections to other people and sometimes struggled to find appropriate ways to engage with them. His support staff encouraged Vadim to join a Next Chapter Book Club,

and it quickly became obvious that Vadim has a wonderful ability to understand complex issues and to formulate



and express relevant opinions. One of the book club members was so impressed with Vadim's insights that she recommended him for membership on The Arc Montgomery County's Public Policy Committee. There, as one of several advocates engaged in protecting the rights of people with disabilities, Vadim began to shine. He listened carefully to the discussions and then framed the issues in terms of his

She uses age-appropriate language and her new friends engage her in real conversations and invite her for



play dates. Sophia's parents have been equally embraced by KFICCC families, finding themselves included in every event and activity and welcomed into the community. Sophia's mom is excited about

the "unlimited possibilities" she sees in Sophia's future, and she is grateful to KFICCC for teaching children to accept others who are different.



## **Child Find**

Our KFICCC program collaborated with Montgomery County Child Find to host a diagnostic assessment clinic for children



identified as having possible developmental delays. Children from KFICCC and the

larger community were provided free one-on-one assessments by Child Find staff and then referred to additional resources and services as needed. The partnership has been so successful that Child Find clinics are now scheduled twice annually at KFICCC.


